Entries will be accepted in the order received starting August 1<sup>st</sup>, 2019 thru Sept 27th, 2019 or until trials fill. The fastest, easiest way to secure a spot is to enter online.

- I. Please contact us with your interest in Rat Wrangling, Scribing, Course Building, etc. We need your help to keep these trials running smoothly.
- II. The trial will be held in a barn like setting, not heated or air conditioned, so dress accordingly.
- III. We will accept Move Ups at this trial.
- IV. Day of Show entries will be allowed ONLY if there are any openings.
- V. Barn Hunt is NOT an AKC event. When you are on Barn Hunt grounds you are subject to Barn Hunt rules of conduct. When you are on AKC grounds you are subject to their rules.
- VI. All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE NOT PERMITTED at the show site. Electric collars ARE NOT PERMITTED at the show site.**
- VII. There is **NO SMOKING WITH LIT CIGARETTES or Vape** around the rings. Be at least 50 feet away if you are smoking anything.
- VIII. Please pick up after your dog and **dispose of waste** in appropriate containers—trash cans. Please clean up after yourself too.
- IX. **Bitches in season** MAY compete at Barn Hunt events. They will be ran at the end of each class. Bitches in season must wear pants designed for dogs. If bringing a bitch in season, inform the trial committee prior to the trial, and inform all exhibitors at the judge's briefing.
- X. First through fourth place qualifying ribbons will be given.
- XI. Rosettes for New Titles.
- XII. Refunds offered only for injured dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- XIII. **Lunch will be on your own.** We will take a lunch break. You are responsible to get back to the Barn Hunt rings on time for trial 2.
- XIV. Every attempt will be made to hold this event as scheduled. In the event of an "Act of God" such as fire, flood, etc., an event may be canceled. We will make every attempt to contact entrants and inform them of the cancellation. We will return all or part of the entry fees at our discretion.
- XV. **A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks.**
- XVI. **Disruptive dogs** will have to be crated a good distance from the ring. If your dog cannot handle other dogs or people walking past their crate, plan to crate farther away from the ring.

**We are fortunate to have a hotel that will accept the huge number of dogs that attend a national. You are responsible for picking up after your dogs around the hotel, and all the show sites on the grounds. Be courteous. Be responsible.**

**This is the fourth year we have held Barn Hunt trials at the DPCA National. We had wonderful volunteers the last time. Please volunteer this year to help at the ring and with course building. Working together we will make this a successful and fun event.**
